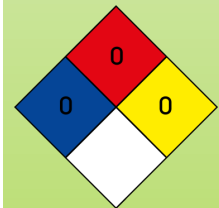
APPLICATION

DIRECTIONS FOR USE

Greencare Rust Remover is commonly applied on the surface by a brush or by spraying. The solution can range from 10 - 50 % and is left to react for 15 - 20 minutes, after which the cleaned items are rinsed off with water and a brush. Small parts can be soaked in a prepared solution.

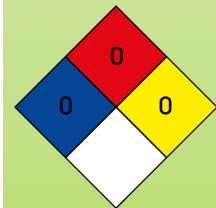
